INTRODUCTION

We are pleased the 49th Annual Institute will return to an in-person program this year and look forward to seeing everyone in South Bend. As in the past, the Institute offers topics that cover both transfer tax savings and practical topics, relevant for a broad range of clients, even for clients who are not exposed to the estate tax. Two sessions focus on what to expect during an audit of gift and estate tax returns, the new approaches the IRS has been taking in its audits, and how to respond during the audit. Two other sessions address factors and objectives that need to be considered when drafting long-term trusts and what trust jurisdiction can best accomplish these objectives. Because the treatment of trustees under the grantor trust rules are different from the treatment of trustees for the gift and estate taxes, another topic will address the circumstances when a spouse or a descendant can be a trustee without estate tax exposure. Another session addresses a topic not often covered—the use of the preferred partnership for encumbered real estate to create income tax savings and how these income tax savings can be increased if the underlying real estate is refinanced before the owner of the preferred partnership interest dies.

By allocating 60 minutes to each session, the speakers will be able to provide a brief review of the fundamental principles and factual background a topic will be using.

Our speakers are encouraged to use numerical examples when explaining how a planning technique accomplishes its tax savings objectives. The participant can use the speaker's examples to communicate the planning technique to a potential client in an understandable manner.

We hope that our broad range of practical and useful sessions will be of value to you as we return to the camaraderie of our in-person Institute.
