Douglass Cassel is an attorney, scholar and commentator specializing in international human rights law, especially with regard to issues of business and human rights, regional human rights systems, and international criminal and humanitarian law, as well as public international law. He is former founding Co-Chair of the Business and Human Rights Lawyers Association, established in 2022 by leading global law firms; former President of the Board of the Justice Studies Center of the Americas, to which he was elected four times by the Organization of American States; and former President of the Due Process of Law Foundation. He has served as consultant or counsel on human rights to the United Nations, Organization of American States, United States Department of State and Department of Justice, the Government of Colombia, the Government of Poland, the Ford Foundation, and numerous non-governmental human rights organizations.
